## 一. 申請類別和條件(請選一項,剔於格內)

## □ 專業會員

申請人需從事專業插畫三年或以上,本會將以申請者的「經驗」、「技巧」、「創意」和「個人風格」作出評價。

## □連繋會員

申請人包括目前未符合專業會員資格的插畫師、從事與插畫相關行業如設計、廣告、設計教育等人十、及設計、插畫學生等。甄選方式與「專業會員」相同。

## □升格為專業會員

若申請人現為本會的連繫會員,希望申請升格為專業會員。本會將以申請者的「經驗」、「技巧」、「創意」、「個人風格」和「對會務的參與度」作出評價。

# 二. 遞交申請表和作品集

- 1. 本會每年招收新會員一次。
- 2. 申請人請於2018年11月11號前遞交申請表和作品集,逾期恕不受理。
- 3. 申請表和作品集必須為電子檔案,並電郵至本會:hksi.application@gmail.com, 恕不接受郵寄文件。申請人可以提供個人網頁, 但只作甄選之參考。遞交申請表必須為pdf 格式。作品集必須包括十張作品。每張作品約為500k,只能採用jpeg格式。每張作品必須編 號,作品編號必須與 (表三) 的資料相符。
- 4. 申請者必須於「一.申請類別和條件」內清楚選擇申請界別,此分別為:專業會員、聯繫會員、升格為專業會員和機構會員。若沒有填上,均只作聯繫會員申請處理。
- 5. 申請者表上所有項目,包括個人資料、(表一)、(表二)、(表三)、均必須填寫清楚。

#### 五. 甄選方式

- 1. 每屆的評審小組均由獨立的5位專業會員組成並輪任,一人一票,就專業會員和連繫會員申請者的「經驗」、「技巧」、「創意」和「個人風格」公平選出。機構會員將以申請者的「宗旨」、「形象」、「表現」作評審。
- 2. 落選者可以於下年度再提出申請,並將由新的評審小組再行甄選。
- 3. 連繫會員可待取得專業條件,再申請升格為專業會員。本會將以申請者的「經驗」、「技巧」、「創意」、「個人風格」和「對會務的參與程度」作出評價。
- 4. 如有需要,委會員會跟個別申請者進行面試。 (將於該年十一月進行,時間地點將另行通知。)

#### 六. 甄選結果及通知

- 無論入選與否,本會於該年十二月將結果以電郵及書面通知閣下, 閣下必需簽署及寄回「入會通知書」以確認入會程序。
- 2. 申請人於得知甄選結果後,本會將另行通知閣下繳交會費。(無需在申請階段繳交。)

# **HKSI Membership Application Form**

Hong Kong Society of Illustrators Limited ("HKSI") is a professional organization. We welcome any professional illustrators, as well as other people who are working or studying in the field of illustration, to join us. HKSI was established to promote the professional status of illustration art and offer support and encouragement to our members.

1.	Application Categories and Requirements (please check one)

	Full Membership Applicant should have at least 3 years of experience as a professional illustrator. HKSI will review applicant's submission in terms of : experience, technique, creativity and personal style.
	Associate Membership Applicant includes illustrators who do not fulfill the 'Full Member' requirement, professionals working in a related field, and illustration student. The Associate Membership selection process will be the same as the Full Membership selection process.
	Upgrading to become a Full Member  For applicant who is currently an associate member and would like to apply for full membership, the evaluation will be based on the applicant's experience, technique, creativity, personal style and devotion to the association.

#### 2. Application Forms and Portfolios Submission

- 1. We recruit new members once a year.
- 2. New applicants should submit the application form and portfolio for our review on or before the deadline on 11 November 2018. Late applications will not be reviewed.
- 3. All application forms and portfolios must be in digital files and email to us at hksi.application@gmail.com. Any forms or portfolio sent via mail will not be reviewed. As supplementary information, applicants may also submit a link to their websites. Application form must be in PDF format. Portfolio must include 10 pieces of work. Each piece of work should be approximately 500k and in jpeg format ONLY. Each piece of work should be numbered in the order as shown in Table 3.
- 4. Applicants are required to state the category they are attempting to apply. Those who fail to do so, will be automatically categorized as an Associate Membership applicants.
- 5. Every section on the forms must be completed legibly, including personal information, Table 1, 2 and 3.

#### 5. Portfolio Review

- 1. Jury committee is formed by 11 Full members of HKSI. The portfolio will be judged by applicant's experience, technique, creativity and personal style.
- Applicants who fail this year can re-submit the application in the following year. Another committee will review the portfolio.
- 3. Successful Associate Member can reapply as a Full Member once they have got the required qualifications. The evaluation will be based on the applicant's experience, technique, creativity, personal style and devotion to the association.
- 4. Some applicants might be required to have a face-to-face interview. The interview will take place in November; time and location will be notified.

#### 6. Results and Notifications

- 1. Whether the application is successful or not, the results will be sent to the applicants via email and post in December. Applicants must sign back the "membership notification letter" to confirm their membership by post.
- 2. HKSI will notify the successful applicants the details of membership payment. (Do not submit any payment when you submit the application).

#### 7. Membership Benefits and Responsibilities

- 1. Receive our membership cards, newsletters and network news.
- 2. Participate in HKSI activities such as group shows, seminars and promotional activities.
- 3. Have your works shown on HKSI web page. (There is a special section for Associate Members)
- 4. Right to use the suffix of HKSI: Full Member 's =HKSI(fm), Associate Member's =HKSI(am).
- 5. Responsibility to pay the membership fee on time, to attend the annual meeting and contribute suggestions.
- 6. Responsibility to support the HKSI activities voluntarily.

#### 8. Termination of Membership

If an HKSI member would like to terminate his or her membership, the member must notify the association in written document.

#### 9. Membership Fee

Full Member: HK\$ 770 per annum

Associate Member: HK\$ 440 per annum

Corporate Member (Legally registered organization): HK\$ 1500 per annum

Corporate Member (Creative industry, organizations, institutions): HK\$ 800 per annum

Successful applicants will be notified to pay the membership fee after the selection process (Do not submit any payment when you submit the application)

Members are required to pay on time. A penalty fee will be charged for late payments.

#### 10. Applicant's Declaration
